One approach that we are all familiar with is to begin by taking an inventory when we are trying to identify areas that need improvement. We're going to think about the changes we're experiencing right now in our service bodies and in our communities, and the main challenges we are encountering when trying to provide NA services.

Scanning gives us the opportunity to look at the internal and external factors that affect our groups and the ways we provide service. In the last several years, we have all experienced huge changes to the ways we provide and participate in service – but in many cases, our structures have not caught up with these changes. We can be prisoners of our own guidelines, and the ways we define and think about service positions might be very different from how they actually work now.

SUGGESTIONS FOR THE HOME GROUP

a) Group Communication Plan:

1. Establish one home group member to be the contact person for all other home group members.

2. The contact person should have home and/or office email and a phone with voicemail.

3. In the event of an emergency, group members can phone or email him/her and relay their status and whereabouts, and he/she can in turn inform other group members when they check in.

b) NA Meeting Time and Location:

1. Check the location of your meeting place.

2. If your regular meeting place has been damaged or destroyed or you cannot reach it, set up a new location, or electronic meetings.

3. NA meetings can be held anywhere during an emergency.

c) Area Service Committee Update:

1. Contact the member of your Area Service Committee leadership team that has been designated as the emergency point of contact.

2. Be sure to give them detailed information of where your meetings are being held and the correct times.

d) Disaster Supply Kit:

- 1. A current Regional Directory; state and local maps;
- 2. Up-to-date addresses and phone numbers for each home group member;
- 3. Extra copy of meeting format, the Little White Book, the Basic Text;
- 4. Notepad and pens (to leave notes on doors);
- 5. Candles and matches or one working flashlight with spare batteries.

6. It is important that one set of these materials be kept in the group meeting place and one set kept in a separate location in case the meeting place cannot be reached or has been damaged.

We carried 41 out of47 presentations last month. Two were missed because of Debby, two because the facility had covid and two were our fault last minute illness. We voted in Danniel to the Men's Cove panel and Rachel in as panel leader for River Oaks. We voted to allow the Jail presentation to be carried by one person in an emergancy. This required a 2/3 majority as are policy requires at least two. We discussed this, and because the jail presentation is always monitored by a deputy, we felt this covered the safety concerns. It is important that we always cover this presentation as this facility will not tolerate no-shows.

We discussed about the possible reimbursement if requested for the \$15 back-ground check required by the Created Women's facility. As we ran out of time this was tabled until next month meeting.
