Treasurer's Report:

Hello everyone,

On July 1, 2024, the opening bank balance was \$30,915.77. After deposits of \$18,798.40 and expenses of 7,539.92 on August 31, 2024, the ending book balance was \$42,174.25. After deducting \$10,000.00 withheld for the next RSC, the Prudent Reserve of \$11,000.00, the GSR Assembly Reserve of \$4,800.00, and the Florida Service Symposium Reserve of \$5,250.00 the available balance was \$11,124.25. After discussion, I proposed to withhold the Island Nation travel budgeted amount of \$4,200.00 from the donation to NAWS. A check was written to **NAWS**

for \$7,124.25.

As of RSC held on September 15, 2024, we received \$1,450.29 in income and had \$6,675.65 in expenses. Additionally, we allocated the monthly reserve of \$350.00 for the GSR Assembly & \$800.00 the Florida Service Symposium. Therefore, after RSC business the available balance was 548.89. *This does not match what was read on the floor due to adjustments during final reconciling prior to submitting reports.
